A BILL

For an ordinance authorizing capital equipment purchases in the General Government Special Revenue Fund.

WHEREAS, the Department of Transportation and Infrastructure (DOTI) is seeking approval to purchase two (2) side-loading organics collection vehicles to refresh the aging Solid Waste Management (SWM) fleet and serve disproportionately impacted communities in Denver that previously did not have equitable access to curbside composting services; and

WHEREAS, the purchase of said vehicles supports the Colorado Department of Public Health & Environment “2023 Front Range Diversion Grant” program award, approved under Resolution No. 2008, Series of 2023; and

WHEREAS, said purchase will be authorized from the DOTI “2023 Front Range Diversion” grant appropriation (11955-5000000); and

WHEREAS, said vehicles are over the \$50,000 threshold for capital equipment items that require City Council approval, per the Denver Revised Municipal Code; and

WHEREAS, this Ordinance authorizes the purchase of said vehicles;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From the “2023 Front Range Diversion” Grants Fund, Accounting No. 11955, the Executive Director of the Department of Transportation and Infrastructure, or duly authorized representatives, is hereby authorized to purchase or acquire the following capital equipment:
