22 County Building located at 1437 Bannock Street, in Denver, Colorado.

23 **Section 2.** Other Notices. The proponents of the districts shall give any statutorily
24 required notices.

25 **Section 3.** That the Clerk of the City and County of Denver shall attest and affix the seal
26 of the City and County of Denver to this Resolution.
