**A BILL**

**For an ordinance making rescissions from the General Fund and Capital Improvement Funds; making appropriations in the General Fund to make cash transfers; making appropriations in the General Fund, Special Revenue Funds and the Capital Improvements and Capital Maintenances Fund to address 2022 and 2023 needs; and authorizing the purchase of capital equipment.**

**WHEREAS**, the Department of Safety wishes to apply 2022 savings from the Denver Sheriff Department to hallway paint and tile replacement projects at the County Jail and to capital equipment needs for the Denver Fire Department and Denver Sheriff Department, including fingerprint machines, body scanners, a mounted vehicle unit, gas detectors, calibration stations and tablets and; and

**WHEREAS**, the Denver Public Library, wishes to use 2022 savings for the Decker Branch Library Renovations, including ADA improvements and to purchase material hold lockers and a video wall; and

**WHEREAS**, the City needs to reallocate current year savings in the Denver Health Operating Agreement to cover increased costs at public health clinics; and

**WHEREAS**, the City wishes to reallocate savings from an existing Clerk and Recorder project in the Capital Improvement Fund to the Elections Equipment Special Revenue Fund to purchase a ballot sorter; and

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund and the Capital Improvements and Capital Maintenance Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
