For a resolution approving and providing for the execution of a proposed amendment to the grant agreement approved by ordinance 904 series of 2016 between the City and County of Denver and the United States Department of Health and Human Services concerning the "Denver Great Kids Head Start" program and the funding therefore.

WHEREAS, the City and County of Denver has given due consideration to said proposed Amendment to the Grant Agreement;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement, under CFDA No. 93.600, between the United States of America and the City and County of Denver, which is identified as Grant Number 08CH1119-04-01, a copy of which is duly filed with the City Clerk, Filing No. 16-0404-001, be and hereby is approved in all respects.

Section 2. The payments made by the United States of America to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 11000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said "Head Start FY16-17" Program, Accounting No. 11002-0104101-Y1001 is as follows, to be expended by the Director of the Mayor's Office for Education and Children:

The foregoing authorization will provide cost of living adjustments for services (education, nutrition, health, mental health, disabilities and family services) to 1,153 eligible children. Authorization for expenditure of said funds following execution of said grant will cover the period from July 1, 2016 to June 30, 2017.
