5 **ABILL**

6 **For an ordinance designating 1555 North Grant Street as a structure for**  
7 **preservation.**

8 **WHEREAS**, pursuant to Section 30-4, Denver Revised Municipal Code, the Landmark  
9 Preservation Commission has transmitted to the Council a proposed designation of a structure for  
10 preservation; and

11 **WHEREAS**, based upon evidence received by the Landmark Preservation Commission at a  
12 hearing on January 6, 2026, the staff report, and evidence received at the hearing before City Council  
13 on February 9, 2026, the structures at 1555 North Grant Street meets the criteria for designation as a  
14 structure for preservation as set out in Section 30-3, Denver Revised Municipal Code, as amended, by  
15 maintaining its integrity, being more than 30 years old, and meeting the criteria in the following four  
16 categories from Section 30-3(3):

17 *b. Having direct and substantial association with a recognized person or group of persons*  
18 *who had influence on society;*

19 The two event halls, one constructed in 1928 (the “1928 Event Hall”) and one constructed in 1963 (the  
20 “1963 Event Hall”) (together, the “Event Halls”), at 1555 North Grant Street are associated with Knights  
21 of Columbus District 539, which served both Denver’s Catholic community as well as the greater  
22 community at-large. The location one block from the State Capitol and the Cathedral of the Immaculate  
23 Conception, as well as proximity to downtown, provided a central location for use by the Catholic  
24 community, community groups, and general members of the public. To accommodate the mid-20th  
25 Century growth in membership and the community’s changing needs, the Knights of Columbus  
26 reconfigured the property in the early 1960s adding the second event hall and creating an onsite parking  
27 lot.

28 *c. Embodying distinctive visible characteristics of an architectural style or type;*

29 The 1963 Event Hall embodies the distinctive visible characteristics of the Mid-century Modern  
30 architectural style. This is seen in the building’s clean, simple lines, flat roof, lack of ornamentation,  
31 mixing of concrete and brick, vertical bands of windows, and exploitation of modern technology.

32 *d. Being a significant example of the work of a recognized architect or master builder;*

33 The 1963 Event Hall is a significant example of the work of recognized architect John F. Milan,  
34 due to its inventive incorporation of its structural form (prestressed double tee concrete) as a

1 design element. The 1963 Event Hall is likely Denver’s earliest example of the use of prestressed  
2 slabs in this way and, as such, is a unique example of Milan’s work.

3 *e. Containing elements of architectural design, engineering, materials, craftsmanship,*  
4 *or artistic merit which represent a significant innovation or technical achievement;*

5 John F. Milan designed the 1963 Event Hall with prestressed concrete double tee framing members,  
6 a new concrete structural form developed by engineers for Prestressed Concrete of Colorado, Inc.,  
7 a firm, owned and operated by the Perlmutter Family. It is an example of the building industry looking  
8 to develop new materials after World War II due to the ongoing shortage of traditional building  
9 materials . While ubiquitous today, at this time, the use of prestressed concrete double tee framing  
10 members was a unique and innovative design approach.

11 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
12 **DENVER:**

13 **Section 1.** That based upon the analysis referenced above, and the evidence received at the  
14 public hearings, certain property at 1555 North Grant Street, and legally described as follows, together  
15 with all improvements situated and located thereon, be and the same is hereby designated as a  
16 structure for preservation:

17 Lots 31 through 40, Block 37,  
18 H.C. Brown’s Addition to Denver, Colorado,  
19 City and County of Denver,  
20 State of Colorado.

21 **Section 2.** The period of significance for the property at 1555 North Grant Street, legally  
22 described above, is 1928 to 1982.

23 **Section 3.** The Event Halls situated and located on 1555 North Grant Street, legally  
24 described above, are contributing structures; all other structures and features on 1555 North Grant  
25 Street, legally described above, are noncontributing.

26 **Section 4.** The effect of this designation may enhance the value of the property and of the  
27 structure, but may delay or require denial of building permits found unacceptable by the Landmark  
28 Preservation Commission under the criteria contained in the Design Guidelines for Historic Structures  
29 and Districts and Section 30-6 of the Denver Revised Municipal Code.

30 **Section 5.** This ordinance shall be recorded among the records of the Clerk and Recorder of  
31 the City and County of Denver.
