6. General description of proposed ordinance including contract scope of work if applicable:

This ordinance request is for a \$640,000 supplemental to the Transfer to the Business/Community Investment Fund (01010-9911500) that is managed by the Office of Economic Development (OED). This fund supports the business attraction and retention efforts of OED. This supplemental request will fund three business development opportunities, one an attraction of a new facility and two for retention of existing Denver-based facilities and employment. The three business development opportunities total 878 jobs and an associated \$104.4 million in capital. The estimated direct fiscal benefit is \$4.35 million, or ROI of \$6.68 for every dollar spent.
