A BILL

For an ordinance making a rescission from and an appropriation in the Capital Improvements and Capital Maintenance Fund.

WHEREAS, Ordinance No. 1193, Series of 2019, appropriated funds for the 18th/19th Multimodal Improvements project; and

WHEREAS, said project installed transit-only and protected bike lanes on 18th and 19th Streets between Wynkoop and Welton in 2022 and was successfully completed under budget; and

WHEREAS, the City desires to transfer capital program budget from the completed multimodal transportation project to the Denver Moves Implementation Project to support final design and installation of the Sherman St Protected Bike Lane project between E Colfax Ave and E 19th Ave;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the Capital Improvements and Capital Maintenance Fund there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
