A BILL

For an ordinance naming the park at 2140 West Asbury Avenue as “La Lomita Park”.

WHEREAS, the City County of Denver annexed the land on which the park sits, sometimes known as “Asbury and Tejon” Park, City and County of Denver, in 1962, located at approximately 2140 West Asbury Avenue, Denver, Colorado 80223; and

WHEREAS, the land was ultimately acquired by the City from Denver Urban Renewal Authority in 1995 and in 2002;

WHEREAS, the park was fully designated in accordance with City Charter in 2017; and

WHEREAS, in accordance with the procedure established by the Department of Parks and Recreation’s Naming Policy, residents of southwest Denver submitted a petition to name the park at 2140 West Asbury Avenue “La Lomita Park”; and

WHEREAS, the Manager of the Department of Parks and Recreation supports the proposed naming of this park and the Denver Parks and Recreation Advisory Board voted at its meeting on August 8, 2018, to recommend the naming of the park at 2140 West Asbury Avenue as “La Lomita Park”.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the park at 2140 West Asbury Avenue be and the same is hereby named, and shall be known as, LA LOMITA PARK.

Section 2. That this action shall be effective upon the final adoption of the ordinance.
