13 **(\$131,994.11) made payable to Bryan and Terrill Law, PLLC; and One Hundred**  
14 **Eighty-Three Thousand Five Dollars and Eighty-Nine cents (\$183,005.89)**  
15 **made payable to the Denver Probate Court, in full payment and satisfaction of**  
16 **all claims related to Claim Number 2021-005614 brought by the estate of**  
17 **Steven Nguyen and Rafael Landeros arising from an incident which occurred**  
18 **on March 19, 2018 involving officers from the Denver Police Department.**

20 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

22 **Section 1.** That the Council of the City and County of Denver hereby approves and authorizes

25 Twenty-Five Thousand Dollars and no Cents (\$25,000.00) made payable to Bryan and Terrill Law,  
26 PLLC; One Hundred Thirty-One Thousand, Nine Hundred Ninety-Four Dollars and Eleven Cents  
27 (\$131,994.11) made payable to Bryan and Terrill Law, PLLC; and One Hundred Eighty-Three  
28 Thousand Five Dollars and Eighty-Nine cents (\$183,005.89) made payable to the Denver Probate  
29 Court, in full payment and satisfaction of all claims related to Claim Number 2021-005614 brought  
30 by the estate of Steven Nguyen and Rafael Landeros arising from an incident which occurred on  
31 March 19, 2018 involving officers from the Denver Police Department.

32 Payment is to be made upon the execution and delivery of such release or releases as is or  
33 are satisfactory to the attorney for the City and County of Denver.
