Request to revise Council Bill No. CB-14-0016, Ordinance No. 73, Series of 2014

A. Seeking approval and revisions to delete within Purpose 8 the Shared Parking Project for Denver Museum of Nature and Science and Denver Zoo for \$4,400,000, and add the following Projects which were approved the Bond Executive Committee on May 7, 2013:
