Repeal D.R.M.C. Section 53-514 – Imposition of fee for committing and discharging convicted inmates to and from the county jail. Consistent with the provisions of C.R.S. 30-1-104(1)(n), the director of corrections and undersheriff shall charge a processing fee of thirty dollars (\$30.00) (the “fee”) to each convicted inmate committed or discharged from the county jail.

Amending D.R.M.C. Section 53-515 – Utilization of annual revenues generated from fee for committing and discharging convicted inmates to and from the county jail. The revenues generated annually from the fee for committing and discharging convicted inmates authorized pursuant to section 53-514 shall be distributed as follows:

- (20) percent of the revenues generated from the fee to administer a community-based treatment program
- (20) percent of the revenues generated from the fee for training, at the discretion of the manager of safety,
- The balance of the revenues to defray the costs of processing prisoners into and out of custody.

This repeals the collection of the \$30.00 Inmate Processing Fee and amends the utilization of the fund until all such revenues have been expended. There is fee generates approximately \$350,000 annually with a 30% collection rate into a special revenue fund. Those inmates that were not convicted can request a reimbursement of the fee.
