	Child welfare Citizen Review Panels were established nearly three decades ago in state statute and in Denver Revised Municipal Code, as the process for grievances related to child welfare cases.  The Colorado General Assembly has made changes to state statute that make child welfare citizen review panels redundant and inoperable as a process for child welfare grievances. These state law changes created new processes for child welfare grievances through the statewide Child Protection Ombudsman office. These law changes also removed our authority as a county department to share private child welfare case information with citizen review panels, so we can no longer use them for grievances.							
	We are requesting to repeal the city's ordinance on child welfare citizen review panels, to align and comply with state laws.
