Neighborhoods & Planning

- BR14-1029 Grants authority to the City to acquire through a negotiated purchase or condemnation all or a portion of any property interests in the property generally located at the 3300 block of Brighton Boulevard, extending west to Arkins Court, for the purpose of creating: (1) a new 33rd Street from Brighton Boulevard to Arkins Court and, (2) a "Festival Area" extending north from the proposed 33rd Street to 35th Street.

Safety & Well-being

- BR14-0992 Approves the no-cost second annual extension of the contract with the Keefe Commissary Network through 12-31-15 to provide commissary services and accounting software for inmate accounts at the County Jail and Downtown Detention Center (RC63008).
- BR14-0995 Amends a contract with The Colorado Coalition for the Homeless to extend the term through 12-31-15 and to add \$1 million to provide outreach services to homeless youth and adults, making at least 6,500 contacts with homeless individuals during the new term (SOCSV-2013-14442-01).
- BR14-1000 Amends a contract with Volunteers of America Colorado Branch to add \$416,000, for a new total of \$832,000, and extend the term one year through 12-31-15, to provide housing for families and single women when all of the City's emergency shelter beds are full, and to add Health Insurance Portability and Accountability Act (HIPAA) language (2013-14480-01).
- BR14-1004 Amends Chapter 42 of the Denver Revised Municipal Code to establish the 2015-2017 salary and fringe benefits of the command staff for the Police Chief, Deputy Chiefs, Division Chiefs, and Commanders per the Collective Bargaining Agreement.
- BR14- Amends a contract with the Colorado Non-profit Development Center to

- 1018 add \$549,025 (for a new contract total of \$1,550,153.30) and a 1 year extension (for a new end date of 12-31-15) in order to continue jail to community reentry services for incarcerated persons, with services provided by the Community Reentry Project (SAFTY-201208794-03).
- RR14- Approves the Mayoral Appointment of Stewart Lundy to the Denver
1027 African American Commission for a term effective immediately and expiring on 11-26-16, or until a successor is duly appointed.
- RR14- Approves the Mayoral appointment of Mustafa Al Qaisi, Paul Ameen,
1033 Pilar Castro-Reino, Jennifer Gueddiche, Maricruz Herrera, and Karima Osman to Denver Immigrant & Refugee Commission for terms effective immediately and expiring 12-31-16, or until successors are duly appointed.

Routine, non-controversial requests for ordinances that are not substantive policy changes may be placed on Consent Agendas for Council Committees each week with the approval of Committee chairs. Councilmembers receive the consent agendas for review and have until Thursday at noon to request that an item be scheduled for Committee discussion. If approved, items are placed on the Mayor-Council agenda the following week. This document outlines the items that were placed on consent agendas this week.
