5 **A BILL**

6 **For an ordinance making rescissions and supplemental appropriations from**  
7 **the General Fund Contingency to Departments.**  
8

9 **WHEREAS**, Community Planning and Development has incurred unbudgeted overtime and  
10 on-call expenses to maintain on-time performance for plan review and inspection services; and

11 **WHEREAS**, the Denver Police Department has experienced an increase in unbudgeted  
12 overtime primarily associated with vacancies at the Denver International Airport and a mid-year  
13 change in how the Denver Broncos compensates officers who provide security inside the stadium,  
14 from direct payments to through the City; and

15 **WHEREAS**, the Office of Human Resources has incurred unbudgeted personnel costs due  
16 to market equity adjustments, the 24-hour flex program, and retirement payouts; and

17 **WHEREAS**, the Denver Fire Department has experienced an increase in unbudgeted  
18 overtime to cover plan reviews, increased leave usage, and leave payouts; and

19 **WHEREAS**, the Clerk and Recorder incurred unbudgeted printing costs to accommodate a  
20 historically long ballot; and

21 **WHEREAS**, the North Denver Cornerstone Collaborative requires ongoing support for a  
22 Portfolio Integration Manager for projects in the River North Area because the funding source was  
23 eliminated once the Brighton Boulevard project was completed; and

24 **WHEREAS**, Human Rights and Community Partnerships incurred unbudgeted expenses  
25 including an increase in sign language services to meet demand and mid-year personnel  
26 adjustments; and

27 **WHEREAS**, Denver County Court incurred unbudgeted personnel expenditures including  
28 the retirement of long-term employees whose separation from the City resulted in significant  
29 payouts for vacation and sick time; and

30 **WHEREAS**, the Office of Emergency Management incurred unbudgeted expenses including  
31 replacing a damaged siren and salary adjustments;
