6 **For an ordinance to change the name of the “Mayor’s Office of Workforce**  
7 **Development Private Grants” Fund to the “Denver Economic Development**  
8 **and Opportunity Private Grants” Fund.**

10 **WHEREAS**, the Mayor’s Office of Workforce Development Private Grants Fund, Fund  
11 number 17602, was created to administer private grants when Economic Development programs  
12 were administered through the Mayor’s Office instead of a standalone department; and

13 **WHEREAS**, since then, the Office of Economic Development was created, which was  
14 renamed Denver Economic Development and Opportunity; and

15 **WHEREAS**, the Denver Economic Development and Opportunity is the sole expending  
16 authority of private grants in Fund 17602;

18 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
19 **OF DENVER:**

21 **Section 1.** The “Mayor’s Office of Workforce Development Private Grants” Fund, Accounting  
22 No. 17602, in the Economic Opportunity Special Revenue Fund Series, is hereby named the “Denver  
23 Economic Development and Opportunity Private Grants” Fund.

24 **Section 2.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
25 and directed to make such book and record entries and to do such other things as may be necessary  
26 to accomplish the purposes of this Ordinance.
