9 For an ordinance authorizing the Mayor and other proper officials to enter into a
10 contractual agreement with the State of Colorado for a "Community Services Block
11 Grant FY10-11" program and the funding therefor.

13 WHEREAS, the City and County of Denver has given due consideration to said proposed
14 Grant Agreement; and

15 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY
16 OF DENVER:

17 Section 1. The proposed grant agreement, under CFDA 93.569 between State of Colorado
18 and the City and County of Denver for a "Community Services Block Grant FY10-11" Program,
19 which is identified as Grant Number L10CSBG13, a copy of which is duly filed with the City
20 Clerk, Filing No. 10-481, be and hereby is approved in all respects.

21 Section 2. The Mayor or his lawful successor and other proper officials of the City and
22 County of Denver, in its behalf, are hereby authorized and directed to execute said Grant
23 Agreement and the Clerk and Recorder of the City and County of Denver is hereby authorized
24 and directed to attest and impress the official seal of the City and County of Denver on the Grant
25 Agreement.

26 Section 3. The Mayor, his successor in office, or his duly authorized representatives, and
27 other officials of the City are hereby authorized and directed to do all things required to be done
28 in order to obtain payments under the Contract, including, but not limited to, filing requests for
29 payments, contracting with persons and organizations in order to carry out the provisions of the
30 Contract, filing reports and keeping records relating to fiscal and evaluation matters, and
31 forwarding other materials to the State of Colorado.

32 Section 4. The payments made by the State of Colorado to the City pursuant to and under
33 the Contract shall be deposited into the Treasury of the City and credited to Special Fund
34 No. 13000, which is set forth and described in Section 20-18 of the Revised Municipal Code of
35 the City and County of Denver.

1 Section 5. That it be and is hereby found and determined that the budget summary of said
2 "Community Services Block Grant FY10-11" Program, accounting number 13007-5511101-
3 H2123 is as follows, to be expended by the Manager of Human Services:

6 Authorization for expenditure of said funds following execution of said grant will cover the
7 period from March 1, 2010 to February 28, 2011.

8 Section 6. The Manager of Finance of the City and County of Denver is hereby authorized
9 and directed to make such book and record entries and to do such other things as may be
10 necessary to accomplish the purposes of this Ordinance.
