**A bill for an ordinance approving and providing for the execution of a proposed Intergovernmental Agreement between the City and County of Denver and the Colorado Department of Transportation (CDOT) concerning the "Sheridan Sidewalks Improvements" project and the funding therefor.**

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Intergovernmental Agreement;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The payments made and pursuant to the proposed Intergovernmental Agreement under CFDA No. 20.205 between CDOT and the City and County of Denver, a copy of which is duly filed with the City Clerk, Filing No. 16-0278, is hereby approved and shall be deposited into the Treasury of the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 2.** That it be and is hereby found and determined that the budget summary of said project is as follows:
