IGA was recently approved where CCD agreed to reimburse Regional Transportation District thirty percent (30%) of Regional Transportation District’s costs and expenses directly related to the Mall Paver Maintenance, up to three hundred thousand dollars (\$300,000.00) annually or three million dollars (\$3,000,000) for a duration of ten (10) years. Audit clause was inadvertently omitted. Adding this clause is the only change being made to the IGA.
