- The proposed contract provides for a three-year agreement extension (2013-2015) that cumulatively exceeds the threshold contained in Section 3.2.6(E)

- Jefferson County Sheriff's Dept provides scheduled, year-round patrol – for prevention and enforcement of park related laws.
- Negotiations between Denver Police and Jeffco Sheriff's department resulted in the fee schedule being modified to remove the monthly Investigative Support Services fee of \$2,205.76; and to increase the reimbursed hourly rate of sheriff's officers by 3% per year – resulting in an overall savings of \$29,117.00 from the prior three-year period.
