A BILL

For an ordinance approving a proposed Intergovernmental Agreement between the City and County of Denver and the Colorado Department of Transportation (CDOT), relating to the "FASTER Safety SH 30 Havana" project and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Intergovernmental Agreement;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Intergovernmental Agreement between the City and County of Denver and the Colorado Department of Transportation (CDOT), in the words and figures contained and set forth in that form of Agreement available in the office and on the web page of City Council, and to be filed in the office of the Clerk and Recorder, Ex-Officio Clerk of the City and County of Denver, under City Clerk's Filing No. 14-0935 is hereby approved.

Section 2. That it be and is hereby found and determined that the budget summary of said project is as follows:

The foregoing authorization establishes a capital grant fund number and appropriates funds to be received from CDOT. Authorization for expenditure of said funds following execution of said contract will cover the period from execution to completion. The City will provide a match for this project of up to \$545,247 of CIP matching funds for a total project funding amount of \$2,726,237.

3 necessary to accomplish the purposes of this Ordinance.
