A BILL

For an ordinance establishing a new Fund in the General Government Special Revenue Fund Series for the “Volume-Based Pricing” program and authorizing appropriations in the new fund.

WHEREAS, Ordinance No. 685, Series of 2022, implemented a volume-based pricing system for trash, including recycling and composting services at no extra charge; and

WHEREAS, implementation costs, which primarily include cart purchases and education campaign along with a cash match for Front Range Waste Division Grant, are needed in 2022 to ensure the program is up and running in January of 2023; and

WHEREAS, the Department of Finance (DOF) requires the creation of a new Fund under the General Government Special Revenue Fund Series, Accounting No. 11000, for revenue and expenditures related to improvements to the Volume- Based Pricing Program;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. A new Fund is hereby established in the General Government Special Revenue Fund Series, Accounting No. 11000, a “Volume-Base Pricing Program” Fund, Accounting No. 11886, for the purpose of accounting for the receipt and expenditure of program dollars.

Section 2. Monies received from General Fund transfers, fee revenue, or other sources of income for Accounting No. 11886 shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 11000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. Program expenditures are hereby authorized for the “Volume-Base Pricing Program” Fund, Accounting No. 11886, to be expended by the Executive Director of the Department of Transportation and Infrastructure. Allowable expenses include program costs to support Volume-

1 Based Pricing programs, including personnel, services and supplies, capital equipment, and
2 appropriated cash transfers to the Capital Improvements and Capital Maintenance Fund for capital
3 projects. The Chief Financial Officer may transfer unused balances in the Fund to the General Fund.
4 This Fund is appropriated and non-lapsing.

5 **Section 4.** That it be and is hereby found and determined that the budget summary of said
6 program, to be expended by the Executive Director of the Department of Transportation and
7 Infrastructure, is as follows:
