Section 4. That the adoption and acceptance of Comprehensive Plan 2040, the Comprehensive Plan Supplements, and of any subsequent amendment or supplement thereto, is

1	intended to establish the same as the official guide for	the officials of the City and County of Denver	
2	and private citizens when making decisions affecting the future character of the City and County of		
3	Denver; provided, however, that such approval shall not preempt the decision making powers vested		
4	by law or the administrative directive in the Mayor, the Council or any other official of the City and		
5	County of Denver with respect to, but not limited to, a zoning map amendment, a zoning language		
6	amendment, a dedication or vacation of a street, alley or other public way, a designation of a park,		
7	the issuance of a revocable permit, a conveyance or the acquisition of real property by the City and		
8	County of Denver, or an appropriation for a construction or a capital improvement; and provided		
9	further, that it is expressly understood that considerable judgment must be exercised in the		
10	application of the Comprehensive Plan 2040 policies to the decision making processes of the Mayor,		
11	Council and other officials of the City and County of Denver.
