A BILL

For an ordinance making an appropriation from the Developmental Disabilities Special Revenue Fund.

WHEREAS, the City’s services for Denver residents with developmental disabilities are funded by a voter-approved, dedicated mill levy; and

WHEREAS, the projected revenue from the mill levy is anticipated to be higher than what was originally appropriated as part of the 2013 budget;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From the Human Services Special Revenue Fund, Accounting No. 13000, out of monies not otherwise appropriated and in addition to the amounts heretofore appropriated by Ordinance No. 657, Series of 2012, and any supplemental appropriations or rescissions there is hereby appropriated to the appropriation account hereinafter designated the amounts of money following each such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
