11	the district attorney in excess of a statutory minimum amount shall be set by the city	
12	council of the City and County of Denver for the second judicial district; and

14	WHEREAS, according to § 20-1-301 (1)(a)(V), C.R.S., the current mandator	
15	minimum salary for district attorneys in Colorado is \$130,000, of which amount the stat	
16	pays 80% as required by § 20-1-306, C.R.S.; a	nd

18	WHEREAS, the city council has conducted a review of the salary of the distri	
19	attorney as required by section 18-97, D.R.M.C. and has determined to adjust the annual	
20	salary of the district attorney as set forth herein.

22	NOW, THEREFORE, BE IT ENACTED BY THE	COUNCIL OF THE CITY AND COUNTY

31	(b) Salary of District Attorney.

1	(1) Effective January 13, 2009 for the calendar year
2	commencing January 1, 2009, the district attorney of the
3	second judicial district shall be paid at an annual salary rate
4	of one hundred seventy seven thousand (\$177,000).
5	
6	(2) Effective January 1, 2010, the district attorney of the second
7	judicial district shall be paid an annual rate of one hundred
8	eighty-seven thousand dollars (\$187,000).
9	
10	(3) Effective January 1, 2011, the district attorney of the second
11	judicial district shall be paid an annual rate of one hundred
12	ninety seven thousand dollars (\$197,000).
13	
14	(4) Effective January 1, 2012, the district attorney of the second
15	judicial district shall be paid an annual rate of two hundred
16	and seven thousand dollars (\$207,000).
17	
18	(1) For 2013 and 2014, the district attorney of the second
19	judicial district shall continue to be paid an annual rate of
20	<u>\$207,000.</u>
21	
22	(2) Effective January 1, 2015, the district attorney of the second
23	judicial district shall be paid an annual rate of \$213,210.
24	
25	(3) Effective January 1, 2016, the district attorney of the second
26	judicial district shall be paid an annual rate of \$219,606.
27	
28	(5)(4) Future reviews of the pay assigned to the district attorney
29	shall be conducted during the calendar year immediately
30	preceding the expiration of the current term of such district
31	attorney.
