2. **Title:** Amends a contract with Smith Agency to add \$332,326.00 for a new total of \$732,326.00 and by reducing the term by three months for a new end date of 9-30-2026 to continue providing out-of-home placement services for unaccompanied refugee minor children/youth ages birth to 18 (or up to age 21 if placed in the custody of Denver Human Services (DHS) prior to their 18th birthday), citywide (SOCSV-202472923-01/SOCVS-202579006-01).

DHS requests authorization to approve a first amendment to the contract with the Smith Agency to add \$332,326 and a reduction of the contract's end date, which will now conclude on 09/30/2026. The purpose of these changes is to ensure the continued services of out-of-home placement services for unaccompanied refugee minor children/youth ages birth to 18 (or up to age 21 if placed in the custody of DHS prior to their 18th birthday). This contract uses alternative funding sources to support out-of-home placement services where State Paid funding is not available. This contract is funded through a grant agreement from Unaccompanied Refugee Minor Program (URM/URMP) through a collaborative partnership between the Colorado Refugee Services Program and the Colorado Department of Labor and Employment - Office of Economic Security. The URM program aims to provide culturally and linguistically appropriate foster care and independent living placements for eligible refugee minors in the United States. The primary objectives of the URM program are to reunite these youth with their families or relatives and to provide programming that promotes their social, cultural, and economic integration.

Scope of work:

Out-of-home placement is a statewide program administered by the City and County of Denver, Denver Human Services, as the Denver county human services department. This program is under direction of Colorado Department of Human Services (CDHS) and subject to current and future regulatory legislation. Contractor shall provide out-of-home placement services for eligible unaccompanied refugee minor children/youth ages birth to 18 (or up to age 21 if placed in the custody of DHS prior to their 18th birthday). Services in this agreement are funded through the URM grant and also closely adhere to CDHS Child Welfare Out-of-home-placement requirements. The services under this Agreement may include, but are not limited to:

- Basic 24-hour care and child maintenance (food, shelter, clothing, educational, supplies, personal incidentals and allowance).
- Administrative overhead and case management.
- Behavioral health services which may include but are not limited to individual, group and family therapy. In-home services and day treatment may be authorized and paid through the child's/youth's Medicaid eligibility. Behavioral health services may also be authorized and purchased directly by the City through the Department's Core Services or URM program.
- Any other URM grant funded services as allowed by the agreement and the funding source.
