**A BILL**

**For an ordinance amending Sections 39-121(c) of the Revised Municipal Code of the City and County of Denver regarding the Schedule for Use of Facilities, specifically for the Denver Zoological Gardens.**

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** Section 39-121 of the Denver Revised Municipal Code is amended by revising subsection (c) to read as follows:

“(3) *City park zoo fees:*

a. Regular fees; single admission:

		March through October	November through February
1.	12 years and over (other than senior citizens) .....	<del>\$17.00</del> <u>20.00</u>	<del>\$13.00</del> <u>15.00</u>
2.	3 years to 11 years, and accompanied by parent or other adult .....	<del>12.00</del> <u>14.00</u>	<del>9.00</del> <u>10.00</u>
3.	Under 3 years and accompanied by parent or other adult .....	No Charge	No Charge
4.	Senior citizen, 65 years and over .....	<del>14.00</del> <u>17.00</u>	<del>11.00</del> <u>13.00</u>
5.	Denver Zoological Foundation members .....	No Charge	No Charge

b. Special days, rates and conditions: The manager of parks and recreation shall designate not less than seven (7) days in each calendar year during which no admission will be charged to residents of the state, and may establish rates or conditions for groups or special parties, and may charge additional rates for groups or special parties from outside of the city. Current members of the Denver Zoological Foundation shall be admitted without charge.

The manager of parks and recreation may also establish rates for business-sponsored periods, including evenings, for the Denver Zoo.
