A BILL

For an ordinance amending Ordinance 880, Series 1992, concerning the "Tree Removal and Replacement" program in the Culture and Recreation Special Revenue Fund and the means for authorizing revenues and expenditures from said fund.

WHEREAS, fund 15711 (formerly special fund 1518) was established by ordinance No. 880, series of 1992 as the "Tree Removal and Replacement" Project Special Revenue Fund; and

WHEREAS, the Department of Parks and Recreation desires to clarify the purpose of the fund;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That Sections 1, 2 and Section 3 of Ordinance No. 880 Series of 1992, are hereby amended to read as follows:

"Section 1. There is hereby established in the Culture and Recreation Special Revenue Fund, Accounting No. 15000, a "Public Tree Canopy" Fund, Accounting No. 15711-7010000, for the purpose of planting and establishing trees in public rights-of-way or other public places.

Section 2. Monies received from any source that are payments for damage to, or loss of, trees on public property, including donations, transfers, or other sources of private receipts, shall be deposited in the Treasury of the City, and credited to Special Fund No. 15000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. Expenditures including personnel, supplies, services, and materials are hereby authorized for planning, plan review, site preparation, planting and maintenance, and other related activities required to promote the successful long-term growth of new trees to maintain or expand the tree canopy on public property. Expenditures are authorized in Accounting No. 15711-7010000, in the amount not to exceed the total of deposits described in Section 2 of this Ordinance, to be expended by the Executive Director of Parks and Recreation." This is a non-lapsing fund.

1 **Section 2.** The Chief Financial Officer of the City and County of Denver is hereby
2 authorized and directed to make such book and record entries and to do such other things as
3 may be necessary to accomplish the purposes of this Ordinance.
