9 For an ordinance making a rescission from the Denver Office of Cultural Affairs  
10 appropriation and making an appropriation in the Culture and Recreation Special

13 WHEREAS, the City and County of Denver desires to combine the function, roles and  
14 responsibilities of the Denver Office of Cultural Affairs with Theatres and Arenas; and

15 WHEREAS, all programs and services within the Denver Office of Cultural Affairs that were  
16 previously funded by the General Fund will henceforth be funded by the Theatres and Arenas  
17 Special Revenue Fund;

18 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF  
19 DENVER:

20 Section 1. From authorizations of expenditures heretofore made and not rescinded, to the
