- BR11-0501 Approves an amendment to the Airport Use and Facilities Lease Agreement with Southwest Airlines to extend the term through December 31, 2011 and for space changes which will require a reimbursement of \$4.1 million to Southwest Airlines (AR 65001).
- BR11-0502 Amends the agreement with Denver Health and Hospital Authority to provide occupational health and safety services at DIA's terminal clinic through June 30, 2011 and to add \$165,000 to the contract (CE 01072).
- BR11-0503 Approves a contract with Interstate Highway Construction, Inc. for the Runway 8-26 Complex Pavement Rehabilitation and ADG V Improvements project at DIA in the amount of \$19,152,540.47 (CE 10041).
