B. <u>Budget and Management - Tom Migaki</u>

BR10-0856 Approves closing out of various grant budgets (\$54,183.38) and cash balances (\$337.03) to be rescinded and transferred to the General Fund.

C. Career Service Authority - Bruce Backer/Roberta Monaco

BR10-0831 A bill for an ordinance amending the classification and pay plan for employees in the Career Service and for certain employees not in the Career Service, to eliminate fixed steps within pay ranges.

BR10-0877 A bill for an Ordinance amending language to remove references to "steps" within the classification and pay plan as it relates to the annual implementation of pay plan adjustments and the salary of County Court Judges and Magistrates.

BR10-0874 Approves text amendment No. 4 to the Denver Zoning Code, correcting section references in several articles regarding detached accessory structures.

BR10-0878 Accepts a grant in the amount of \$465,221.68 from the Colorado Department of Transportation to develop and operate a Sobriety Court which will address repeated offenses for driving under the influence of alcohol and drugs (GC00053-1).

F. Denver International Airport - Brian Elms

BR10-0869 Approves a first amendment to the contract with Avaya, Inc. to add \$1,483,073.50 for the upgrade to the current Communications Manager Voice System at Denver International Airport.

BR10-0734 Revise City Code to no longer require on site proof of vaccination to license dogs or cats; exempt microchipped cats from license display; and make providing false information a violation.

BR10-0880 Approves the 2011 Denver Health & Hospital Authority (DHHA) Operating Agreement. The contract approves City expenditures in the amount of \$51,534,600 for DHHA services for the City and the City to receive funds in the amount of \$1,399,522 for City services provided to DHHA.

BR10-0857 Grants a utility easement to Forest City in conjunction with the City's land acquisition for the Stapleton Library Bond Project in Council District 11.
