Aquila Services Corporation doing business as Denver Metro Protective Services will provide emergency on-call security personnel services Citywide, excluding Denver International Airport. Emergency security personnel services consist of security service outside of normal programmed scheduled services covered under the citywide security personnel services contract. Emergency service requests will be limited duration service engagements such as providing service for cold weather sheltering sites when activated. The initial 3-year contract term will begin on May 1, 2025, and end April 30, 2028. The term may be extended for two (2) one (1) year renewal terms upon written amendment prior to the expiration of the current term.
