35 and have submitted to the Council of the City and County of Denver a plat of such proposed
36 subdivision under the name and style aforesaid, showing the adjacent streets and platted territory,
37 accompanied by a certificate of title from the attorney for the City and County of Denver; and
38 dedicating the streets, avenues, waste water easements, and other public places as shown thereon.
39 **WHEREAS**, said subdivision was surveyed by or under the direction of the City Engineer of the
40 City and County of Denver and said City Engineer has certified as to the accuracy of said survey and
41 said plat or map and their conformity with the requirements of Chapter 49, Article III of the Revised
42 Municipal Code of the City and County of Denver, and said plat has been approved by the City
43 Engineer, the Manager of Community Planning and Development, the Manager of Public Works and
44 the Manager of Parks and Recreation;

1 **NOW THEREFORE,**

2 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

3 **Section 1.** That the Council hereby finds and determines that said land, territory, or real
4 property has been platted in strict conformity with the requirements of the Charter of the City and
5 County of Denver.

6 **Section 2.** That the said plat or map of C.P. Bedrock Filing No. 4 and dedicating to the City
7 and County of Denver the streets, avenues, wastewater easements, and other public places as shown
8 thereon, be and the same are hereby accepted by the Council of the City and County of Denver.
