This request is for a contract with World Wide Technologies (WWT) to provide technical professional services at Denver International Airport (DEN). DEN maintains network infrastructure that provides services to all DEN facilities. DEN's network provides connectivity, transport for data, wireless, data center compute and storage, video, and voice services. It is designed and maintained using Cisco equipment and products. DEN's connectivity is a combination of dark fiber, DSL, routing, and switching. It operates 24x7x365 and carries several mission-critical functions, including airport operations, parking, financial services, public safety, public-facing wireless services, and physical security networks. The services that will be provided under this contract include: (1) account support to ensure that DEN receives excellent service with the chosen vendor partners; (2) a partner that employs Cisco technical resources (Professional-Services) able to work on and install all Cisco products and related services within DEN's infrastructure; and (3) training, webinars, and documentation.
