5 **A BILL**

6 **For an ordinance authorizing a rescission and appropriation in the General**  
7 **Fund, to make a transfer to and appropriation in the Affordable Housing Fund**  
8 **Property Tax and Other Local Revenue Special Revenue Fund.**  
9

10 **WHEREAS**, the Mayor’s 2025 Proposed Budget includes \$12 million for temporary rental  
11 and utility assistance (TRUA) to stabilize those at risk of displacement and \$2 million for eviction  
12 legal assistance; and

13 **WHEREAS**, the City desires to transfer \$8 million from 2024 General Fund savings to the  
14 Affordable Housing Special Revenue fund for TRUA use in 2025;

16 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
17 **OF DENVER:**

19 **Section 1.** From appropriations here to made from the General Fund listed or indicated in the  
20 following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation  
21 under the heading "Amount Rescinded":

23 **Section 2.** From the General Fund, Accounting No. 01010, out of monies rescinded from  
24 Section 1 and from cash balances in said fund not otherwise appropriated and in addition to amounts  
25 heretofore appropriated by Ordinance No. 1682, Series of 2023, and any supplemental  
26 appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter  
27 designated the amount of money following such designation, to be expended for the purposes and  
28 upon the authorizations in said Ordinance set forth:

7 supplemental appropriations or rescissions, there is hereby appropriated to the appropriation  
8 accounts hereinafter designated the amount of money, following such designation, to be expended  
9 for the purposes and upon the authorizations in said Ordinance set forth:
