9 **For an ordinance approving and providing for the execution of proposed**
10 **contracts between the City and County of Denver and the State of Colorado**
11 **concerning the "Community Corrections FY13-14" program and the funding**
12 **therefor.**

14 **WHEREAS**, the State of Colorado, Department of Public Safety, Division of Criminal
15 Justice, has notified the City of funding allocations for Fiscal Year 2013-2014 for community
16 corrections services under a contractual agreement with the City, a copy of which is duly filed
17 with the Clerk and Recorder, Filing No. 09-488; and

18 **WHEREAS**, the State of Colorado, Department of Corrections, Division of Adult Parole,
19 Community Corrections, and Youthful Offender System, has renewed funding for community
20 corrections services under a contractual agreement with the City, a copy of which is duly filed
21 with the Clerk and Recorder, Filing No. 12-0437; and

22 **WHEREAS**, the City and County of Denver has given due consideration to said
23 agreements;

24 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
25 **OF DENVER:**

26 **Section 1.** The proposed Allocation Letter, between the State of Colorado and the City and
27 County of Denver, a copy of which is duly filed with the City Clerk, Filing No. 13-0591, and
28 proposed grant agreement, CMS No. 43813, a copy of which is duly filed with the City Clerk,
29 Filing No. 13-0592, be and hereby are approved in all respects.

30 **Section 2.** The payments made by the State of Colorado to the City pursuant to and under
31 the Contracts shall be deposited into the Treasury of the City and credited to Special Fund
32 No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal Code of
33 the City and County of Denver.

1 **Section 3.** That it be and is hereby found and determined that the budget summary of said
2 "Community Corrections FY13-14" program, Accounting No. 12302-3501101-S3059, is as
3 follows, to be expended by the Manager of Safety :

4 State of Colorado \$14,290,156.23
5 State of Colorado 510,000.00

6 Authorization for expenditure of said funds following execution of said contracts will cover the
7 period from July 1, 2013 to June 30, 2014.

8 **Section 4.** The Manager of Finance of the City and County of Denver is hereby authorized
9 and directed to make such book and record entries and to do such other things as may be
10 necessary to accomplish the purposes of this Ordinance.
