**A BILL**

**For an ordinance renaming a portion of Rifle Street to Panasonic Way at Peña Station Filing No. 1.**

**WHEREAS**, the hereinafter described portion of right-of-way was previously dedicated as Rifle Street by the Peña Station Filing No. 1 subdivision plat, recorded in the real property records of the Office of the Clerk and Recorder of City and County of Denver on August 12, 2015 at Reception Number 2015112439;

**NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The Council hereby approves the renaming of the hereinafter described right-of-way in the City and County of Denver, State of Colorado from Rifle Street to Panasonic Way:

ALL THAT PORTION OF RIFLE ST DEDICATED BY PENA STATION FILING NO. 1, RECORDED AUGUST 12, 2015, AT RECEPTION NO. 2015112439, LOCATED BETWEEN THE SOUTHERLY RIGHT-OF-WAY LINE OF TELLURIDE WAY AND THE NORTHERLY LINE OF 60<sup>TH</sup> AVE.

**Section 2.** That the real property described in Section 1 hereof shall henceforth be known as Panasonic Way.
