THIRD AMENDATORY AGREEMENT

THIS THIRD AMENDATORY AGREEMENT is entered into this day of
, 2010, by the CITY AND COUNTY OF DENVER, a municipal corporation of the
State of Colorado (the "City"), and HS2 GROUP LLC fka EXPRESS PERSONNEL, INC.
and aka EXPRESS SERVICES, INC. and EXPRESS EMPLOYMENT
PROFESSIONALS, LLC whose address is 98 N. Wadsworth Blvd., Unit 124, Lakewood, CO
80226 (the "Contractor").

RECITALS

- A. The City and the Contractor entered into an Agreement dated October 30, 2007, an Amendatory Agreement dated November 25, 2008, and a Second Amendatory Agreement dated December 29, 2009 to perform temporary worker placement services (the "Agreement").
- B. The City and the Contractor now wish to amend the Agreement by increasing the funding.

NOW, THEREFORE, the parties hereby amend the Agreement as follows:

- 1. Subsection A of Paragraph 3 of the Agreement, entitled "<u>Fees and Expenses</u>", is amended to read as follows:
 - "A. <u>Fees and Expenses</u>: Subject to the provisions of Article 3.C. below, the Contractor agrees to accept as full compensation from the City under this Agreement, for completion of all the items of work contained in this Agreement and **Exhibit A**, an amount not to exceed Eight Hundred Fifty Thousand and 00/100 Dollars (\$850,000.00) (the "Maximum Contract Amount"), to be used in accordance with the terms set forth in **Exhibit A**."
- **2.** Except as amended, the Agreement is affirmed and ratified in each and every particular.
- 3. The Third Amendatory Agreement may be executed in two (2) counterparts, each of which is an original of this Agreement and constitutes the same instrument.
