**Hearing Continued** 

The City Council opened the public hearing and heard speakers on June 16. It amended the language to delay from 7:00 AM to 8:00 AM the start time for sales and continued the public hearing to July 14, 2014. At that time, new speakers may address Council, and then the hearing will be closed. Council will then take its final vote on the proposed Zoning Text Amendment on July 14.

## **Proposed Amendment**

Councilwoman Kniech proposes a package of amendments designed to allow sale of certain types of fresh produce and/or cottage food sales from home.

City Council ordered the bill published and set a public hearing
date of June 16, 2014.
Council opened the hearing, heard speakers, amended the start
time for the food sales, and continued the hearing to July 14.
Council will complete the public hearing and take final action
