Desmond G. Fulton - Chief, Denver Fire Department



Fire Chief Desmond G. Fulton has proudly served the City & County of Denver as a member of the Denver Fire Department for over 25 years. He was first appointed as Fire Chief in October of 2020.

With his beginning as a skills-based firefighter, and having a passion for strategy and tactics, Chief Fulton is a leader with a desire for serving and protecting the community, and the very same firefighters he serves with every day.

Chief Fulton attended the University of Northern Colorado and studied Sociology. He was a prior member of USAR (COTF-1), is a current IAFF Executive Fire Officer, credentialed Chief Fire Officer through the Center for Public Safety Excellence, and has written numerous articles for Fire Rescue Magazine. Elias Diggins - Sheriff, Denver Sheriff Department



Elias Diggins was first sworn in as the Sheriff of Denver in July 2020. He has served the Denver Sheriff Department since 1994, holding all uniform ranks with various assignments during his career.

As an advocate for the mental health community, he created a cabinet-level position in his administration titled, "Chief of Mental Health Services," and hired a licensed psychologist to fill the role. Also during his time within the department, he introduced an initiative titled "Gender Equity in Jails Across America," which has also been adopted by the Department of Justice-National Institute of Corrections.

Sheriff Diggins is a nationally recognized law enforcement and corrections leader. He is a past-president of the American Jail Association, and through the American Correctional Association (ACA), he is a former auditor, former commissioner, and past-chair for ACA's Commission on Accreditation for Corrections. He is the recipient of several honors from various organizations,

including recently earning the Community Hope Award from Shorter Community AME Church in Denver.

Sheriff Diggins holds a Master of Public Administration degree from the University of Colorado and a Bachelor of Science degree in Criminal Justice and Criminology from Metropolitan State University of Denver.
