**A BILL**

**For an ordinance making an appropriation from the General Government Special Revenue Fund to the Energy Efficiency Assistance fund.**

**WHEREAS**, the Energy Efficiency Assistance Fund is authorized to receive approximately \$2 million per year in revenue derived from a portion of the Public Service Company of Colorado (Xcel Energy) right-of-way franchise fee to provide energy efficiency programs for individuals and non-profit agencies;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** Expenditures are hereby authorized from the General Government Special Revenue Fund, Accounting No. 11000, the amounts of money in the following tabulation to be expended for the purposes described and upon the authorizations in said Ordinance set forth:
