4 **A RESOLUTION**

5 **Granting a revocable permit to New Cingular Wireless PCS, LLC d/b/a AT&T**  
6 **Wireless, to encroach into the right-of-way at 1465 Wewatta Street.**

7 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

8 **Section 1.** The City and County of Denver (“City”) hereby grants to New Cingular Wireless  
9 PCS, LLC d/b/a AT&T Wireless and its successors and assigns (“Permittee”), a revocable permit  
10 to encroach into the right-of-way with a small cell pole and facilities to include a pole of 27 feet, 5  
11 inches and the antenna on top of the pole at 2 feet, 8 inches, with a total height of 30 feet, 1 inch.  
12 The other items associated with the pole and antenna are: a foundation of 5 feet x 5 feet, 5 feet of  
13 electrical line with conduit, an underground fiber vault with fiber optic cable, and an integrated meter  
14 with disconnect (“Encroachments”) at 1465 Wewatta Street in the following described area  
15 (“Encroachment Area”):

17 Location Description for Pole #7002R02:

18 NW side of Wewatta St. approximately 145FT SW of the corner of 15th St. and Wewatta St.,  
19 adjacent to parcel 02332-16-265 (1490 Delgany St.).

25 **Section 2.** The revocable permit (“Permit”) granted by this Resolution is expressly granted  
26 upon and subject to each and all of the following terms and conditions:

27 (a) Permittee shall obtain a street occupancy permit from City’s Public Works Permit  
28 Operations at 2000 West 3<sup>rd</sup> Avenue, 303-446-3759, prior to commencing construction.

29 (b) Permittee shall be responsible for obtaining all other permits and shall pay all costs  
30 that are necessary for installation and construction of items permitted herein.

31 (c) If the Permittee intends to install any underground facilities in or near a public road,  
32 street, alley, right-of-way or utility easement, the Permittee shall join the Statewide Notification  
33 Association of Owners and Operators of Underground Facilities by contacting the Utility Notification

1 Center of Colorado, 12600 West Colfax Avenue, Suite B-310, Lakewood, Colorado 80215, at 303-  
2 232-1991. Further, Permittee shall contact the Utility Notification Center at 1-800-922-1987 to  
3 locate underground facilities prior to commencing any work under this Permit.

4 (d) Permittee is fully responsible for any and all damages incurred to facilities of the Water  
5 Department and/or drainage facilities for water and sewage of the City due to activities authorized  
6 by the Permit. Should the relocation or replacement of any drainage facilities for water and sewage  
7 of the City become necessary as determined by the City's Executive Director of Public Works  
8 ("Executive Director"), in the Executive Director's sole and absolute discretion, Permittee shall pay  
9 all cost and expense of the portion of the sewer affected by the permitted structure. The extent of  
10 the affected portion to be replaced or relocated by Permittee shall be determined by the Executive  
11 Director. Any and all replacement or repair of facilities of the Denver Water and/or drainage facilities  
12 for water and sewage of the City attributed to the Permittee shall be made by the Denver Water  
13 and/or the City at the sole expense of the Permittee. In the event Permittee's facilities are damaged  
14 or destroyed due to the Denver Water or the City's repair, replacement and/or operation of its  
15 facilities, repairs will be made by the Permittee at its sole expense. Permittee agrees to defend,  
16 indemnify and save the City harmless and to repair or pay for the repair of any and all damages to  
17 said sanitary sewer, or those damages resulting from the failure of the sewer to properly function  
18 as a result of the permitted structure.

19 (e) Permittee shall comply with all requirements of affected utility companies and pay for  
20 all costs of removal, relocation, replacement or rearrangement of utility company facilities. Existing  
21 telephone facilities shall not be utilized, obstructed or disturbed.

22 (f) All construction in, under, on or over the Encroachment Area shall be accomplished  
23 in accordance with the Building Code of the City. Plans and specifications governing the  
24 construction of the Encroachments shall be approved by the Executive Director and the Director of  
25 Building Inspection Division prior to construction. Upon completion, a reproducible copy of the exact  
26 location and dimensions of the Encroachments shall be filed with the Executive Director.

27 (g) The sidewalk and street/alley over the Encroachment Area shall be capable of  
28 withstanding an HS-20 loading in accordance with the latest AASHTO Specifications. The  
29 installations within the Encroachment Area shall be constructed so that the paved section of the  
30 street/alley can be widened without requiring additional structural modifications. The sidewalk shall  
31 be constructed so that it can be removed and replaced without affecting structures within the  
32 Encroachment Area.

1 (h) Permittee shall pay all costs of construction and maintenance of the Encroachments.  
2 Upon revocation of the permit or upon abandonment, Permittee shall pay all costs of removing the  
3 Encroachments from the Encroachment Area and return the Encroachment Area to its original  
4 condition under the supervision of the City Engineer.

5 (i) Permittee shall remove and replace any and all street/alley paving, sidewalks, and  
6 curb and gutter, both inside the Encroachment Area and in the rights-of-way adjacent thereto, that  
7 become broken, damaged or unsightly during the course of construction. In the future, Permittee  
8 shall also remove, replace or repair any street/alley paving, sidewalks, and curb and gutter that  
9 become broken or damaged when, in the opinion of the City Engineer, the damage has been caused  
10 by the activity of the Permittee within the Encroachment Area. All repair work shall be accomplished  
11 without cost to the City and under the supervision of the City Engineer.

12 (j) The City reserves the right to make an inspection of the Encroachments contained  
13 within the Encroachment Area. An annual fee, subject to change, of \$200.00 shall be assessed.

14 (k) This revocable Permit shall not operate or be construed to abridge, limit or restrict the  
15 City in exercising its right to make full use of the Encroachment Area and adjacent rights-of-way as  
16 public thoroughfares nor shall it operate to restrict the utility companies in exercising their rights to  
17 construct, remove, operate and maintain their facilities within the Encroachment Area and adjacent  
18 rights-of-way.

19 (l) During the existence of the Encroachments and this Permit, Permittee, its successors  
20 and assigns, at its expense, and without cost to the City, shall procure and maintain a single limit  
21 comprehensive general liability insurance policy with a limit of not less than \$500,000.00. All  
22 coverages are to be arranged on an occurrence basis and include coverage for those hazards  
23 normally identified as X.C.U. during construction. The insurance coverage required herein  
24 constitutes a minimum requirement and such enumeration shall in no way be deemed to limit or  
25 lessen the liability of the Permittee, its successors or assigns, under the terms of this Permit. All  
26 insurance coverage required herein shall be written in a form and by a company or companies  
27 approved by the Risk Manager of the City and authorized to do business in the State of Colorado.  
28 A certified copy of all such insurance policies shall be filed with the Executive Director, and each  
29 such policy shall contain a statement therein or endorsement thereon that it will not be canceled or  
30 materially changed without written notice, by registered mail, to the Executive Director at least thirty  
31 (30) days prior to the effective date of the cancellation or material change. All such insurance  
32 policies shall be specifically endorsed to include all liability assumed by the Permittee hereunder  
33 and shall name the City as an additional insured.

1 (m) Permittee shall comply with the provisions of Article IV (Prohibition of Discrimination  
2 in Employment, Housing and Commercial Space, Public Accommodations, Educational Institutions  
3 and Health and Welfare Services) of Chapter 28 (Human Rights) of the Revised Municipal Code of  
4 the City and County of Denver. The failure to comply with any such provision shall be a proper  
5 basis for revocation of this Permit.

6 (n) The right to revoke this Permit is expressly reserved to the City.

7 (o) Permittee shall agree to indemnify and always save the City harmless from all costs,  
8 claims or damages arising, either directly or indirectly, out of the rights and privileges granted by  
9 this Permit.

10 **Section 3.** That the Permit hereby granted shall be revocable at any time that the Council  
11 of the City and County of Denver shall determine that the public convenience and necessity or the  
12 public health, safety or general welfare require such revocation, and the right to revoke the same is  
13 hereby expressly reserved to the City; provided however, at a reasonable time prior to City Council  
14 action upon such revocation or proposed revocation, opportunity shall be afforded to Permittee, its  
15 successors and assigns, to be present at a hearing to be conducted by the City Council upon such  
16 matters and thereat to present its views and opinions thereof and to present for consideration action  
17 or actions alternative to the revocation of such Permit.
