## **General Fund Contingency**

The City Charter requires that the proposed budget for the General Fund shall include no less than two percent of total estimated expenditures for unbudgeted expenditures. Fiscal Policy outlines criteria that include:

- An unexpected event such as a natural disaster or accident;
- Large unappropriated payouts or personnel costs such as retirement payout or midyear salary adjustments that cannot be absorbed by agency appropriation;
- Unfunded mandates as a result of legislation;
- Planned one-time expenditures that advance a programmatic or financial outcome.



## Migrant Services

- The Border Crisis Response Special Revenue Fund was established in 2023 to support personnel and program costs related to supporting asylum seekers coming to Denver from outside of the southern border.
- Amount \$1,244,000





#### Transportation and Infrastructure

- Fuel contract still under negotiation
- Aging fleet
  - Increase in outsourced fleet repairs
  - Increase in parts cost and ordering
- Amount \$500,000

## City Attorney's Office

- Outside Counsel
  - Conflict counsel makes up 81% of outside counsel
    - It is most typically used when the CAO is defending the city and a city employee, and the city employee's interests may not align with the city's interests
  - Specialized counsel makes up the balance
    - Bond and disclosure
    - Americans with Disabilities Act (ADA) Department of Justice (DOJ) settlement
    - Environmental
  - Overflow cases are a nominal portion also
    - To support workload issue
- Amount \$500,000



#### **District Attorney**

- Positions hired at a higher rate than budgeted
- Unbudgeted technology services costs for new office space
- Amount \$ 100,000





## Independent Monitor & Office of the Municipal Public Defender

- Positions hired at a higher rate than budgeted
- Pay equity adjustments
  - Pay equity studies are conducted by the Office of Human Resources to align salaries with comparative market salaries
  - These increases may occur after the ensuing budget year has been approved
  - Vacancy savings may offset some of the unbudgeted increases
- Amount \$140,000 OMPD
- Amount \$100,000 OIM

2023 Year-to-Date Expenditures (as of October YTD)



#### Airport Police Expenditures

- No general fund revenue
- Increase to appropriation of \$450,000 for the Internal Billings and Reimbursement Fund:
  - Used to bill Denver Human Services and Denver International Airport for direct services
- Increase in appropriation request to allow the airport to cover all police expenditures



#### TRUA Rescissions | BR 23-1804



### Background

- City Council introduced 23-1845, which called for additional assistance toward temporary rent and utility assistance (TRUA).
- This request is being undertaken to make \$5M available for TRUA in 2024.

## Increase appropriation in fund by \$8M

- Border Crisis SRF
  - \$8M will be rescinded from Denver
     Human Services operating fund
- The source of operating funds for DHS is dedicated property tax





### Capital Rescissions | BR 23-1802



#### Capital Rescissions

- These rescissions are programmed into the approved 2024 budget
- Annual process to review completed projects
- Often, funds become "stranded" within capital programs when projects are complete, requires council action to repurpose funds
- Rescissions from 20+ projects



#### **Rescission Amounts**

- \$4.2M of total rescissions
  - \$3.9M Capital Improvement Fund
  - \$182K Entertainment and Cultural Fund
  - \$93K Wastewater Enterprise Fund
  - \$7K State Conservations Trust Fund


