19	inmate population resulting in increased costs for food, supplies and clothing for the
20	inmates; and
21	WHEREAS, the Department of Parks and Recreation needs budget adjustments
22	due to sick and vacation payouts and an employee settlement; and
23	WHEREAS, Community Planning and Development needs budget adjustments
24	due to an increase in overtime and on-calls to meet workload demands and an increase
25	in limited positions to work on DIA inspections. DIA costs have been offset by
26	reimbursement from DIA; and
27	WHEREAS, Excise and Licenses needs budget adjustments for personnel,
28	services and supplies due primarily to recommendations made in the 2013 medical
29	marijuana audit and the implementation of retail marijuana; and
30	WHEREAS, the Office of the Independent Monitor needs budget adjustments due
31	to higher than budgeted costs for the new positions added as a part of the 2013 budget;

34	adjustments due to a reclassified position;
