The purpose of the UASI grant is to provide resources to first responders on a regional basis to mitigate against, prepare for, respond to and recover from terrorist attacks. The City and County of Denver acts as the fiscal agent for this grant. The funds are used to procure items for agencies in the City and County of Denver as well as the surrounding 9 counties. As part of the FY10 and FY11 UASI grant Evergreen Fire Rescue is receiving telecommunication equipment and installation to become P25 compliant. These requests were vetted through a grant review process established in the region and approved. The purpose of this ordinance is to request permission to enter into an expenditure contract with Motorola on behalf of Evergreen Fire rescue for communications equipment and installation.
