6 **For an ordinance relinquishing the easements established in the Deed of**  
7 **Easement recorded with Denver Clerk & Recorder at Reception No. 1977099893,**  
8 **Book 1446, Page 314, located at 2099 Chestnut Place.**

9 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has  
10 found and determined that the public use, convenience and necessity no longer requires the  
11 easements in the area hereinafter described, and subject to approval by ordinance, has relinquished  
12 the same;

13 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in relinquishing the  
15 easements established in Deed of Easement recorded with Denver Clerk & Recorder at Reception  
16 No. 1977099893, Book 1446, Page 314, in the following area:

17 **PARCEL DESCRIPTION ROW NO. 2019-RELINQ-0000004-001:**

18 TWO PARCELS OF LAND LOCATED IN THE SOUTHEAST QUARTER OF SECTION 28,  
19 TOWNSHIP 3 SOUTH, RANGE 68 WEST OF THE SIXTH PRINCIPAL MERIDIAN, CITY AND  
20 COUNTY OF DENVER, STATE OF COLORADO, ALSO BEING A PORTION OF LOT 15, BLOCK  
21 6, HOYT & ROBINSON'S ADDITION TO DENVER, AND PORTION OF VACATION ORDINANCE  
22 207, SERIES 1960, BOTH FILED IN THE DENVER COUNTY CLERK AND RECORDER'S  
23 OFFICE, SAID PARCELS OF LAND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

33 **NORTHEAST CORNER OF LOT 14.**

35 **THENCE N52°37'37"W A DISTANCE OF 9.24 FEET TO THE NORTH LINE OF VACATION**  
36 **ORDINANCE 207, SERIES 1960; THENCE ALONG SAID NORTH AND EAST LINES OF**  
37 **VACATION ORDINANCE 207, SERIES 1960 THE FOLLOWING (2) COURSES**  
38 **1.) N89°44'00"E A DISTANCE OF 7.29 FEET;**

1 2.) THENCE S00°30'07"E A DISTANCE OF 5.64 FEET TO THE POINT OF  
2 BEGINNING.WHENCE SAID NORTHWEST CORNER OF LOT 14 BEARS S59°48'08"W A  
3 DISTANCE OF 28.78 FEET.

13 DISTANCE OF 6.46 FEET TO THE EAST LINE OF SAID LOT 15; THENCE S14°42'15"E ALONG  
14 SAID EAST LINE, A DISTANCE OF 6.43 FEET; THENCE N52°35'19"W A DISTANCE OF 10.19  
15 FEET TO THE POINT OF BEGINNING.

17 SAID PARCEL CONTAINS 21 SQUARE FEET OF LAND OR 0.001 ACRES, MORE OR LESS  
18 be and the same is hereby approved and that the easements within the above-described area are  
19 hereby relinquished.
