31	Section 1. A new fund is hereby established in the Community Development Special Reven			
32	Fund Series, Accounting No. 16000, a "Property Tax Rebate" Fund, Accounting No. 16818, for the	the		
33	purpose of accounting for the receipt and expenditure of program dollars.			

**Section 2.** Monies received from General Fund transfers and transfers from the Denver Human Services Rebate Fund, Accounting No. 13813, as well as from other city funds, and other sources of income for Accounting No. 16818 shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** Program expenditures are hereby authorized for the "Property Tax Rebate" Fund, Accounting No. 16818, to be expended by the Executive Director of the Department of Housing Stability. Allowable expenses will include costs for program administration as well as payments to program beneficiaries, per program eligibility criteria. The Chief Financial Officer may transfer unused balances in the Fund to the General Fund. This Fund is appropriated and lapsing.
