**A BILL**

**For an ordinance making rescissions from the General Fund; making appropriations in the General Fund to make cash transfers; making appropriations in Special Revenue Funds and the Capital Improvement and Capital Maintenance Funds; and authorizing the purchase of capital equipment.**

**WHEREAS**, Community Planning and Development (CPD) wishes to transfer 2024 savings to the Other Agency Capital Projects Fund to fund the development of an AI-powered plan review permitting software designed to reduce plan review times and enhance compliance accuracy; and

**WHEREAS**, the Department of Parks and Recreation (DPR) wishes to transfer 2024 savings to the Planned Capital Equipment Special Revenue Funds to purchase mowers, turf equipment, and Cardio and Weight Equipment for recreation centers; and

**WHEREAS**, several of the said capital equipment items exceed the \$50,000 threshold requiring City Council approval, per the Denver Revised Municipal Code;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded":
