The proposed ordinance will amend the contract to add an additional \$300,000 of City funds to the First Creek Restoration Project to construct a new bike path. Urban Drainage and Flood Control District is the contracting authority, so funds will be paid to UDFCD.

This agreement is to fund the Final Design, Right-of-Way Acquisition and Construction of Drainage and Flood Control Improvements along First Creek at 56th Ave. The Amendment will add \$300,000 in City funds, bringing contract total to \$6,770,000.

The proposed ordinance request also authorizes the transfer of cash from the Gateway Impact Fees Special Trust Fund (56291) to Public Works Improvement Projects Special Revenue Fund (31050).
