4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**
6 **of land as Pearl Street located near the intersection of East 45th Avenue and Pearl**
7 **Street.**

8 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has
9 found and determined that the public use, convenience and necessity require the laying out, opening
10 and establishing as a public street designated as part of the system of thoroughfares of the
11 municipality that portion of real property hereinafter more particularly described, and, subject to
12 approval by resolution has laid out, opened and established the same as a public street;

13 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening
15 and establishing as part of the system of thoroughfares of the municipality the following described
16 portion of real property situate, lying and being in the City and County of Denver, State of Colorado,
17 to wit:

19 THE WESTERLY 4.00 FEET EXCEPT FOR THE SOUTHERLY 6.00 FEET OF THAT PARCEL OF LAND DESCRIBED AS PARCEL
20 "A" CONVEYED BY WARRANTY DEED TO THE CITY & COUNTY OF DENVER, RECORDED ON THE 3RD OF NOVEMBER
21 2016, BY RECEPTION NUMBER 2016153651 IN THE CITY AND COUNTY OF DENVER, CLERK AND RECORDER'S OFFICE,

16 TWO MONUMENTS 518.53 FEET APART; ONE MONUMENT BEING A 1" SQUARE BAR IN A RANGE BOX AT THE
17 INTERSECTION OF PENNSYLVANIA STREET AND 45TH AVENUE AND THE OTHER MONUMENT BEING A FOUND 2"
18 DIAMETER ALUMINUM CAP STAMPED "JACOBS ENG" FLUSH WITH ROADWAY AT THE INTERSECTION OF
19 WASHINGTON STREET AND 45TH AVENUE.
