The City manages its centralized vehicle fleet through the Department of Transportation and Infrastructure (DOTI), which includes the Denver Fire Fleet. During the budget process, the Denver Fire Fleet identified vehicles requiring replacement due to age and mileage. At this time there are no electric vehicle (EV) options available because of the operational requirements of these vehicles.

The 2026 fleet replacement requests were approved by City Council in the Long Bill (CB25-1813). This request seeks the authorization to proceed with a purchase order for the approved vehicle replacement for the Denver Fire Department operational fleet.
